

**MEDICAL HEALTH CARE BENEFITS UNDER STUDENT HEALTH SERVICE SCHEME AND  
STUDENT WELFARE FUND SCHEME**

1. Students (Malaysian) with an active status is eligible for Student Health Service Scheme and Student Welfare Fund Scheme benefits.
2. Students (non-citizen) with an active status who contributes to insurance company appointed by Universiti Malaya\* is eligible for Student Health Service Scheme and Student Welfare Fund Scheme benefits.
3. These benefits are applicable in University of Malaya Medical Centre (PPUM), government clinics, government hospitals and teaching hospitals only.
4. Students must obtain guarantee letter from Student Health Clinic Universiti Malaya before receiving any treatment or undergoes any operation to obtain Student Health Service Scheme benefits.
5. Students must obtain an approval letter from Deputy of Vice Chancellor (Student Affairs Universiti Malaya) before receiving any treatment or undergoes any operation that involves renting or purchasing of special medical equipment under Student Welfare Fund Scheme. Deputy of Vice Chancellor (Student Affairs) Universiti Malaya has the right to grant either full or partial cost of the treatment.
6. Students are not entitled to benefits under Student Health Service Scheme and Student Welfare Fund Scheme for cost that involves the following treatment:
  - i. Cost of pregnancy and complications, birth, infertility and family planning.
  - ii. Cost for cosmetics or cosmetic surgery
  - iii. Cost of organ transplant, bone marrow transplant or dialysis treatment.
  - iv. Cost of treatment and hospitalization for medical, surgical or dental cases when occurs abroad.
  - v. Cost of HIV and cancer drugs
  - vi. Costs involving treatment and testing for research purposes
  - vii. Costs of CT scan or MRI scan at CIGMIT PPUM
